Shari,

Not only were you fast, I am in favor of the committee's motion as presented.

Tomorrow, we can present a simple legal test to counter all the threats from Murray's lawyers and Town Counsel that we, the residents, don't have a leg to stand on. The test is as follows:

If the detention cells were dis-allowed by Town officials, would the Dept. of Homeland Security - ICE administrative facility and offices still want to locate in the Executive Park ?

If the answer is no, then the facility is a jail and has no reasonable right to be adjacent to a residential neighborhood that has schools, elderly housing, and churches.

If yes, then the detention area, alone, should be located at an isolated secure site for interviews, fingerprinting, photos, and interrogation.

Hanscom Field/Lincoln Laboratory already has significant security precautions in place including extensive security cameras and controlled access. I believe there is also much unused office space there from years of downsizing. I think that location makes a lot more sense.
