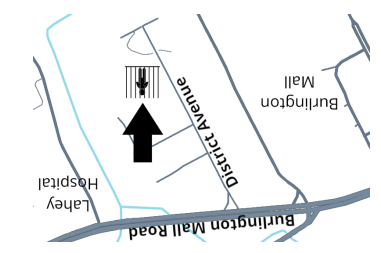


Right behind the Burlington Mall!



Every detainee in New England is put through this repurposed office building, sometimes kept for days or weeks, and they are not provided with basics like beds, showers, medical care, or meals.

The Burlington ICE facility is the regional ICE headquarters for all of New England. ICE has turned this unused office building into an illegal prison.

WHAT IS HAPPENING?

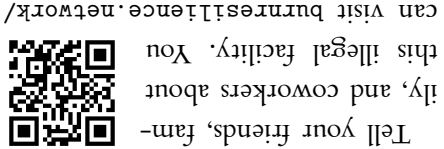

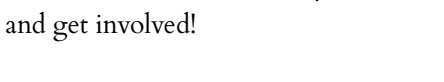
